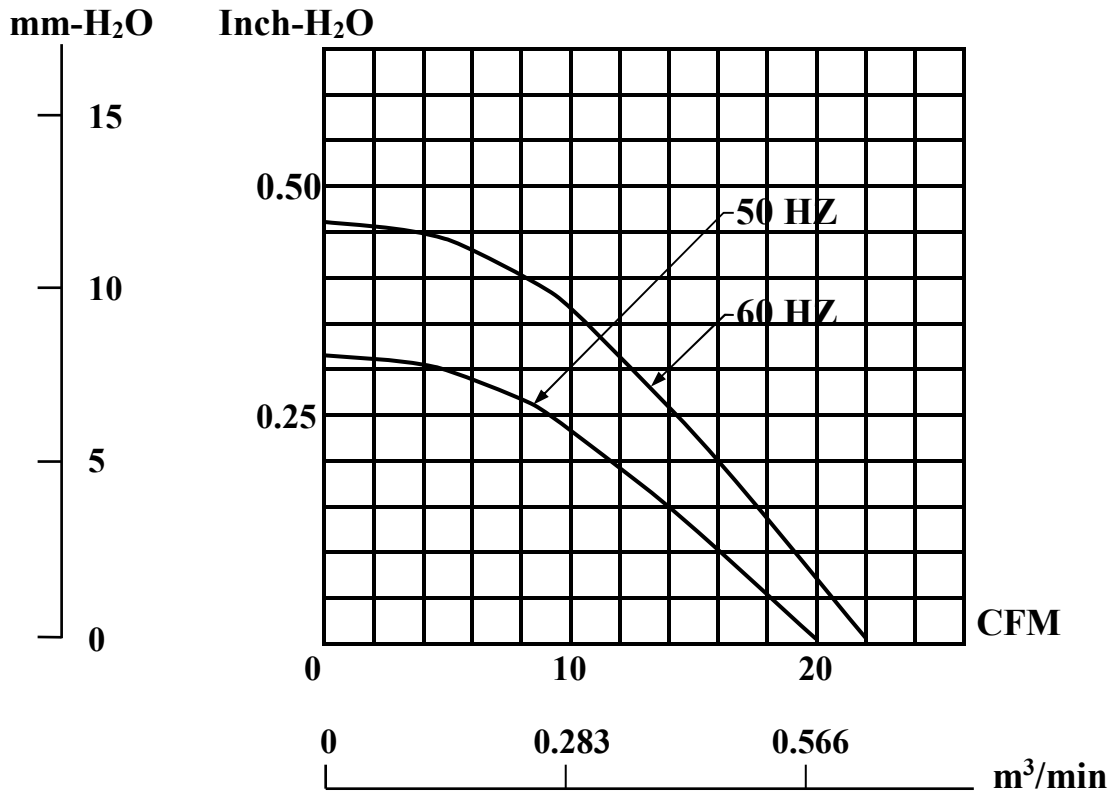

PRESSURE**



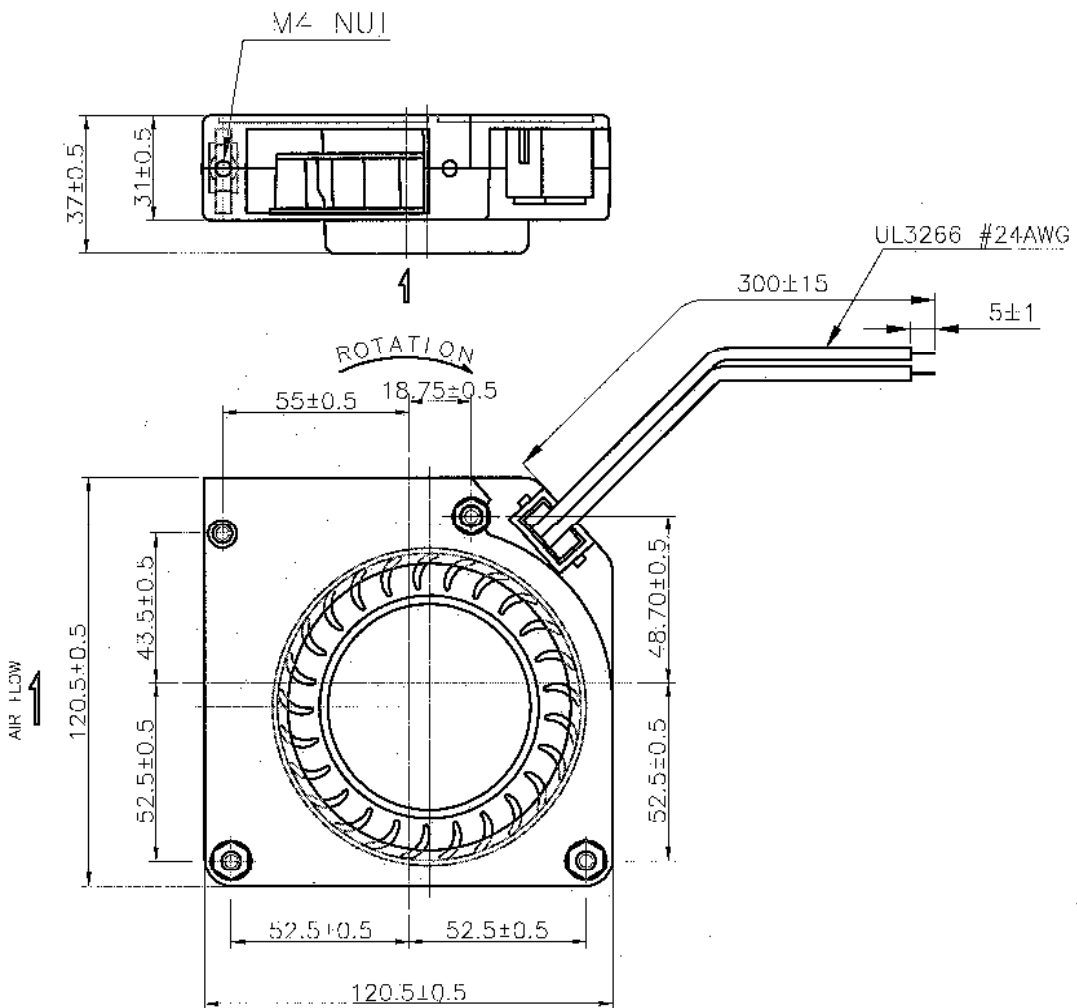
