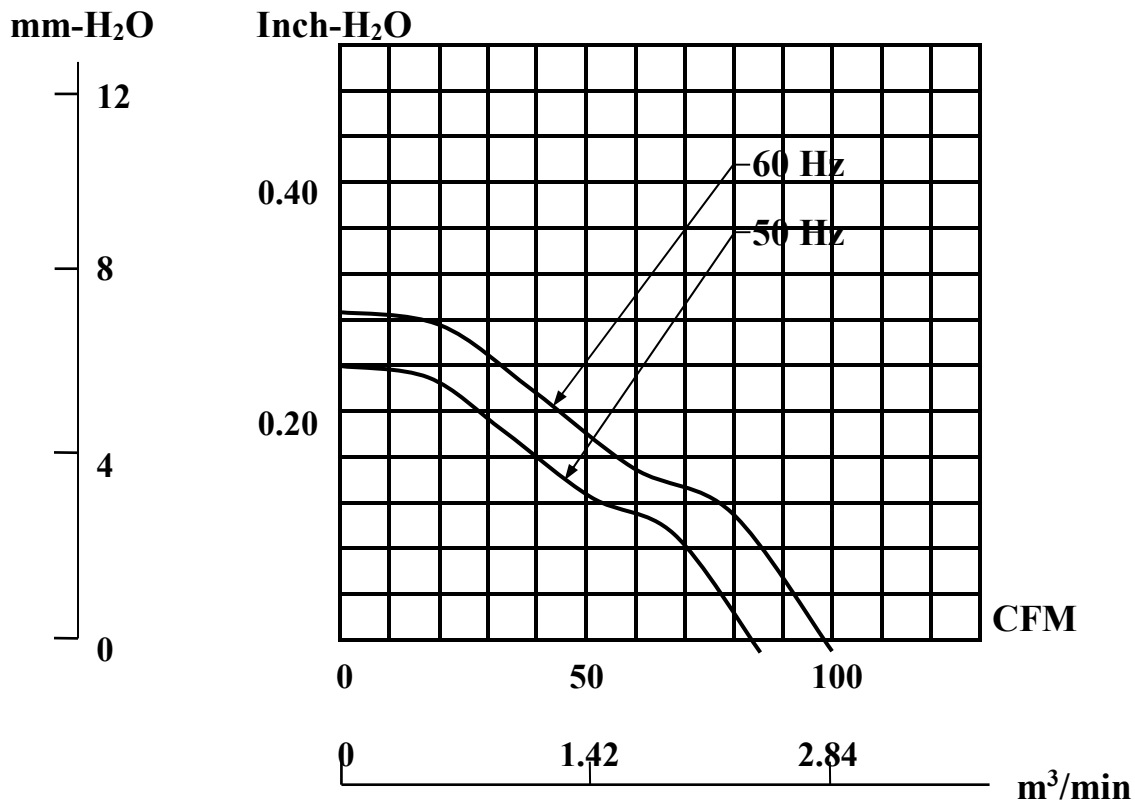

PRESSURE**



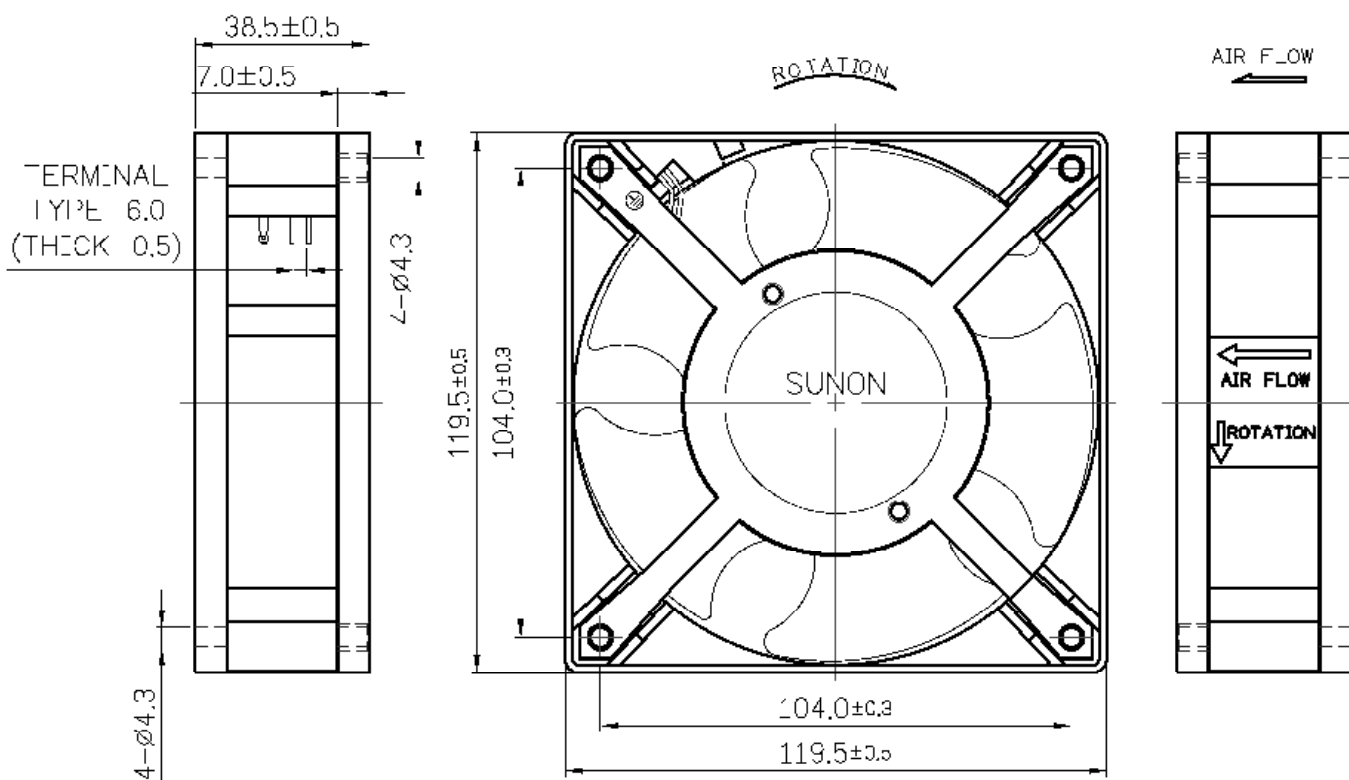
